- p406 Feb. Court 1765 Will of Benjamin Childrey presented by Thomas Childrey, Executor; John Redford and Daniel Stone, Security
- p.406 Robert Sharp, orphan of Henry Sharp, chooses Henry Sharp his guardian; Richard Renard and John Pleasants, Jr., Sec.
- p.417 Feb. Court 1765 Mary Williamson, orphan of John Williamson, chooses Graves Harding her guardian; Dabney Pettus and Turner Southall, Security
- p.427 Feb. Court 1765 Thomas Jerdone, Administrator of estate of Sarah Jerdone, his late wife, a sister and co-heir of William Cocks, dec'd, vs Thomas Watkins, Executor of Francis Redford, dec'd; in this case Robert Pleasants added to list of Gentlemen appointed to settle the estate
- p.434 March Court 1765 Inventory of Thomas Rogers returned. Samuel Gathright, Samuel Gathright, Jr. and William Hobson to lay off and assign to Sarah Rogers her dower in lands of her late husband Thomas Rogers.
- p.441 April Court 1765 Churchwardens of Henrico Parish bind out Chamberlayne Liggon, son of Betty Liggon, and Isaac Scott, son of Sarah Scott
- p.451 April Court 1765 Churchwardens of Henrico Parish bind Samuel, Martha, Jesse, Millenor, Thomas, and Reuben, orphans of Thomas Puryear
- p.454 April Court 1765 Churchwardens of Henrico Parish bind Robert Carter, orphan of Poval Carter
- p. Susanna Puryear, widow of Peter Puryear, complains to court that she is not satisfied with provision her late husband made for her in his will, and renounces her legacy. Dated 30 April 1765. Witnesses: Richard Cottrell and William Jone (May Court 1765)
- p.461 May Court 1765 On motion of Groves Harding and John Redford, who were securities Jacob Burton, dec'd's, guardianship of Mary Alday, they are granted administration of estate of said Burton, having produced a letter from Mary Burton, widow of said dec'd, renouncing her right of administration; Isham Allen and Luzby Turpin, Sec. Thomas Moseley, William Fraysor, Richard Renard, and Abraham Bailey to appraise.
- p.463 June Court 1765 Will of Isaac White proved and recorded
- p.463 June Court 1765 Mary Alday chooses Josiah Bullington, her guardian; Thomas Childrey and Nicholas Giles, Sec.
- p.463 June Court 1765 Churchwardens of Henrico Parish bind Pompey Scott

- p.464 June Court 1765 Margaret Puryear, widow of Thomas Puryear to appear to show cause why she should not give security for her husbands estate
- p.474 July Court 1765 Churchwardens of Henrico Parish bind Sarah Scott and Joseph Scott, children of Nan Scott
- p.474 July Court 1765 Will of Miles Gathright presented by Miles and William Gathright, Executors, and proved; Robert Spears and Jacob Ferris, Security
- p.475 July Court 1765 Will of John Pleasants, Jr. presented by Thomas Pleasants, Jr. and Robert Pleasants, Jr. and proved by James Williamson and Mary Younghusband (a Quaker); Philip Mayo, Isaac Younghusband, and Charles Woodson, Security. Robert Pleasants, Charles Woodson, Samuel Gathright and William Hobson to appraise
- p.476 July Court 1765 Tarlton Woodson, William Pledge, Thomas Poindexter and Richard Pleasants to appraise estate of John Pleasants, Jr. in Goochland County
- p.477 Aug. Court 1765 Matthew Hobson appointed guardian to Matthew Hobson in place of Samuel Hobson; Samuel Hobson and William Hobson, Security.
- p.478 Aug. Court 1765 Inventory of Jacob Burton recorded
- p.480 Aug. Court 1765 Probate granted to Catherine White and Bowler Cocke on the will of Isaac White; Thomas Watkins and John Royster, Sec. Samuel Gathright, Samuel Gathright, Jr., Ephraim Gathright and John Hales to appraise estate.
- p.498 Richard Sharp, Matthew Cobb and Mary his wife, Edward Parker and Susanna his wife, an infant under the age of 21 by the said Edward her husband and next friend, and Robert Sharp, an infant under age 21 by said Richard Sharp- Complainants, Against- Henry Sharp, Defendant: This day came the parties by their counsel and the arbitrators in this suit who were appointed to divide the slaves in the mentioned, now returning the award. Property divided between the above in these words: "In obedience to order of Henrico Court March 1765, to divide the slaves of Mary Sharp, we have allotted unto Robert Sharp the negroes Rachel and little Caesar, Value £ 50; to Richard Sharp Philis and Samson, value £ 50; to Edward Parker in right of his wife Susanna, Jemmy and Bidy, value £ 50; to Matthew Cobb in right of his wife Mary, Caesar and little Judy, value £ 65; to Henry Sharp, Judy and her young child, value £ 35; Henry is to recover from Matthew Cobb £ 15. Dated March 1765. Signed: William Frayser, Charles Woodson, Thomas Childrey. Ordered that division be confirmed (August Court 1765)
