According to a letter from Mrs. R.L. "Della" Brooks she says, "Traditions says Henry White's father landed in Pennsylvania about 1728, from England. then moved into Northern VA, then came to the Waxhaus in S.C. (Lancaster Co.) I have a copy of his land grant in 1761. He came to site of Glenn Springs about the year of 1755. (Note from her says this couldn't be right because she has proof he was still on the Catawba in 1755 and also 1758.) The Catawba was in York Co. S.C. (She has this Henry White confused with the one who was in York County, and died there.)

The settling of Col. White's estate is recorded in Book B. Page 283, R.M.C. Office, Spartanburg, S.C. 1788.

Marker put in cemetery with Cap. Benjamin West, who was hung by the Torys.

Another note inserted in original list/letter from Mrs. R.L. Brooks by her: (White Records of Col. Henry White's family and descendents were supposed to have been copied from White Bible at Javan Barnett's near Columbia, S.C. in the year 1906, by Rufus West and revised by W.J. White)." I have tried to find this Bible but no one seems to know where it is now."

Letter from Mrs. R.L. Brooks to John William White April 10, 1975 says his grave is near the old William Smith farm in upper Union Co.

Letter also says that tradition says Henry White's father landed in PA. about 1728 from England, then moved to Northern VA. then came to the Waxhaus S.C. (Lancaster Co. S.C.). (This is wrong.)

In one document it says he and his wife were buried in their garden. Said to be in the Waxhaws Settlement before moving to Glenn Springs.

From Patriots at Cowpens by Bobby Gilmore Moss:

Henry White, who resided on Fairforest Creek in Spartanburg Dist. S.C., was in the engagements at Mudlick, Blackstock's Plantation, Cowpens, Guilford Courthouse, siege of Ninety Six, and Eutaw Springs. After being wounded at the battle of Mudlick, the ball remained in his body until his death. He became a Lieutenant Colonel after the battle at Cowpens. When Spartanburg County was first laid off, Col. White was appointed one of the seven justices of the peace by Gov. Moultrie.

At bottom it says: Carolina Spartan April 24, 1856, June 4, 1879, July 9, 1879.

This is from some correspondence from Rev. Henry White sent by Dave Edelen.

"Col. Henry White was born on . He lived near Fair Forest Creek in the lower end of Spartanburg County, S.C., and when he died he was buried beside his wife in the garden. Since then it has become a family grave yard. He served in the Revolutionary War as a Colonel. he was in the battle of "MudLick"(Laurens Co.) where he was wounded. Also, as he was engaged in battle of "Blackstock's Ford", and on "Tyger River", where he was again wounded. At the Battle of "Cowpens", Spartanburg Co., S.C., where he was again wounded, carrying the ball in his body until his death. It was said Col. White deserved the credit next to if not equal to Gen. Danial Morgan for the victory at "Cowpens"!!

Hello Jackie,

Attached is a very old pic of Co. Henry White in his uniform. It hung on my grandmother's wall for as long as I remember. It was in a very anctient looking, ornately carved wooden frame. It appears to be an old "Pen & Ink" drawing. I hope you can open it. If so, then give me a hollar and I will send you photos of his grandson, Hiram White (my g.g.g.grandfather), and photos of Hiram's son and daughter-n-law, John Warren White and his wife, Isabella Jane McDowell, and photos of their son and daughter-n-law, Rev. William Henry White and his wife, Carolina Hamilton Stenhouse. I also have a photo of a Confederate soldier in uniform that was in a box along with other family pics under my grandmother's bed. I am not sure who he is, but I am sure he is either a White or a relative. The uniform matches a discription of the uniform of the Palmetto Sharpshooters, South Carolina Vols. John Warren White and three of his brothers served in the P.S.S.s. I wonder if it is not he but a few years of age apart from the other pic of he and his wife?

I also have some pics (Haven't been scanned yet, and of course my scanner broke!) of my great grandfather's brother Edward Walker White and his wife, Leota Alice Kirk (they settled in Amarillo, Texas and opened a store there called White and Kirk), and pics of their children, Edward Dean White and his sister. I also have a pic of their store taken in those "Old West" days.

It is my will & wish that after my death, my wife, Agatha shall continue upon & inherit my land so long as she may live a widow, or untill my youngest child may arrive at the age of twenty one years, at which time, or at the intermarriage of my said wife with any other man, I hereby will that my Executor, hereinafter named shall expose the said land to public sale, after giving reasonable notice, at twelve or eighteen months credit, as he may Judge most advisable, and that the monies arising from said sale shall be equally divided amongst all my children.

I further will that my daughters Polly & Ann Keep to their own use a bed and furniture each & I wish their mother to allot said beds to them in order to prevent dissatisfaction between them. I also allow the said Polly & Ann to have each a young cow or heifer which they now claim.

I further will that my wife shall take and retain, for the use of the family, all the rest of the beds & furniture that I may dispose of & after the children are raised to the full age she may dispose of the beds & furniture as she may think proper. And as much as I am involved in some debts, though none of considerable magnitude, I hereby Order that all the residue of my personal property be appraised & sold in the common form, & reasonable credit, for the purpose of discharging all the Just demands that may stand against me, and that the Overplus /if any/ be equally divided among my wife and all the children, share and share alike, ---- [this line is marked over: except my son Henry White and my daughter Salley Rakestraw, who is not to have any part in this first mentioned division] ---- I except my smallest shot gun & wish her to be kept for the use of the family untill the youngest of my sons and come of age & then he is to have the said gun.

Anyway, my g.grandfather's father, John Warren White, from Spartanburg, S.C., a member of the "Palmetto SharpShooters", was killed in the Civil War. In fact, so were three of his brothers. The only one of old Hiram White's sons out of five to survive the war wsa a Jasper "Jack" White. He also went to Texas after the war. He had two sons that I know of named Bert and William. Jasper or "Jack" was one of our family legends or heroes that I heard about when I was growing up. I would like to communicate with his descendants. Wouldn't it be something if the Whites out there that you mentioned were some of his people!!?? I would like to communicate with these White relatives of yours. Do they have an e-mail address? John Warren White married Isabella McDowell in Spartanburg Co., S.C.. They were the parents of Rev. William Henry White.

After John's death in the Civil War (died at Petersburg, VA October 1864) Isabella married James Calvert in 1866. In that year, due to South Carolina being infested with "Carpet Baggers", and all sorts of yankee filth, they and some relatives migrated first to Upshur County, TX and then to Cooke County, TX where she died the following year.

They made the trip to TX by wagon train and River boat. The black friends and workers that were going with them were turned back at the border of North Carolina, as no blacks were allowed in that area. Only one black man, a wagon driver for James H. Calvert, was allowed to go on. He remained and settled in Upshur Co., TX when the others moved on to Cooke Co., TX.

Lots of problems were among the normal life for them and the wagon train. While they were docked along the Mississippi River, a wheel fell off one of their wagons into the river and had to be retrieved. They had to sleep on their wagons while on the river boat to protect their property.

Isabella was a religious person who felt that Sunday was a holy day, God's day, and would not work or travel on the Sabbath. When on the wagon trains, they would stop Saturday night and not move until Monday. They would do all their cooking and washing on Saturday night to last until Monday. They had a large iron pot for boiling clothes, etc., and the young children liked to beat on it, tapping out music. Isabella would not allow them to do it on Sundays, because she felt the Sabboth was a day of reverence and quiet.

Henry White in Alabama (my gr granddad), "Uncle Jack" wound up in the Texas Mental Institution. His son William hung around but "Berdie" had gone to Montana. Samuel F. White v. Mahala White (maiden name Wyatt)

Action started by complaint dated May 24, 1870 and filed with F. M. Trimmier, Clerk of Court, on June 1, 1870. This case was heard before Judge Thomas O.P. Vernon.

Samuel White and Mahala Wyatt were married on April 25, 1841 by John Wright, Esquire. Two children were born to this marriage. According to Samuel F. White, trouble began after about six years of marriage. Mrs. White admitted committing adultery with Dr. Gideon H. King and this continued until the defendant assaulted the plaintiff with a piece of plank. Mr. White further stated that his wife told him that one of their two children wasn't his. The defendant was last heard of living near Atlanta, Georgia. Fernando White testified against his mother (the defendant) and stated that she had carried off his father's property and that he had seen the property at Mrs. King's house at Glenn Springs. The documents don't state whether this divorce was granted.

I found this short bio on P.P. "Pack" Bogan at findagrave.com. It looks as if it was researched and written by a Dennis and Linda Tackett Price Hinkle.

Pack was the son of Charles Cotesworth Pickney Bogan and Martha Ann Parham. Pack was a younger brother to Dr. Charles P. Bogan who preceded him to Hazel Valley in about 1869. Dr. Bogan moved to Detroit, Red River Co, Texas but Pack remained in Hazel Valley. He married Christian White in Union Co, South Carolina in about 1864. Pack and Christina arrived in Hazel Valley between the birth of their fourth and fifth child, naming the latter, Arnett Charley Bogan. Possibly naming him after the small community of Arnett or a family friend and neighbor of the Arnett family. P. P. Bogan had served in the Confederate Army, Company B, 15th South Carolina Infantry. He was wounded during a battle and left the Army as a Sergeant. Pack served his community at Arnett and Hazel Valley filling such positions as Justice of the Peace, Postmaster, and School Board member. He and Christina parented six boys and five girls. They were, in birth order, Minnie and Willie 1866; Dessy 1867; Mattie C. 01 Dec 1871, who was born in Atlanta, GA; Arnett Charely 29 Jan 1874; Maggie Eva Aug 1877; Lola M 05 Jan 1879; Myrtle 1881; Dexter B 10 July 1882; Dayton 1883; Grover Cleveland Oct 1885 who served as a Washington Co Sheriff's Deputy. .

Biographical Sketches, Micajah Cicero Barnett, Jr.

Elder Macjah Cicero Barnett, nephew of Elder Joroyal Barnett, was born May 20th, 1818 [Barnett/Foster Bible Record states 13 Mar 1802] near Cedar Springs, Spartanburg County, S.C. Was licensed to preach the gospel by the Cedar Springs Baptist Church November 27th, 1841, and ordained March 25th 1843. The presbytery consisted of Elder John G. Landrum, Elias Rogers and Felix W. Littlejohn. He intermarried with Miss Nazareth Lipscomb, daughter of Edward Lipscomb, Esq., a worthy deacon of Goucher Creek Church. [Nazareth's mother was Juliet Lancaster, dau/o William and Clarymond Golightly Lancaster, buried in Lancsaster Cemetery on Foster Mill Circle, Pauline.]

His early education was limited, but, by earnest application and constant devotion to his studies, he was recognized as one of the ablest self-educated men of his day. This combined with his fine personal appearance and social qualities made him attractive as a preacher and agreeable as a companion. His counsel was often sought for by his brethren, and in his intercourse with men his aim was to instruct and benefit. With the exception of two years he lived and labored within the bounds of the Broad River Association, to which he was greatly attached; for many years he was its clerk and for several its

moderator, and was universally loved by the whole association. Although this body may deeply feel the loss of this great and good man, his churches and the community in which he lived have sustained a loss not easily repaired. He supplied at different times during his ministry, Cedar Springs - his mother church - Philadelphia, Sulphur Springs, Gilead, Limestone, Pacolet, Shelby, and at the time of his death he a member and pastor of El Bethel Church, where he had preached with acceptance and much success for three years. He died on the 20th, September, 1872 in the town of Shelby, Cleveland County, N.C., in

the 55th year of his age, and under the watch and care of his numerous friends and sympathizing brethren, on the night previous to the assembling of the 21st annual session of the King's Mountain Association, which body on hearing of his demise, passed the following tribute of respect for one whom they dearly loved:

"Whereas, We have heard with unfeigned sorrow, of the death of Elder M.C. Barnett who departed this life in Shelby, within the bounds of our Association, on the night of the 10th inst., cut down in the prime of his manhood and in the midst of his usefulness, at a time too, when, to his family and to his churches, there seemed to be so much need of him; therefore

Resolved, That in the death of Elder Barnett the churches have lost a faithful pastor and able preacher, the State an upright citizen, the cause of religion - to set forth not only in his teachings but also in his life, a successful advocte - his family a wise and affectionate husband and father.

Resolved that we tender our sympathies to the bereaved family in their affliction, and pray that it may be santified by Him who hath smitten them, to their well being in this life and to their ever-lasting joy in the world to come."

His funeral discourse was delivered by Elder John G. Landrum, to a large and sympathizing concourse of people over his his grave at El Bethel Church, where he was buried with Masonic honors. And now El Bethel Church has taken steps to erect a suitable monument to his memory. May success crown the effort, for he richly deserved such a memento.

Friendship Minutes:

Ssunday before the 1st Lords day Oct. 1873

The Broad River Association as the Church to continue to the fund to erect a monument over out Beloved Brother the Reverand M.C. Barnett who was well known amongst us and sserved the association as Moderator a long time. The church agreed to assist in erecting the monument. A M Smith Clerk

We first met Elder M.C. Barnett at El Bethel Church in 1842. At that session of the Association he made his first appearance as a delegate, and was then an ordained minister. He was frequently dubbled the "Biblical Oracle," so thorough was his knowledge of the Scriptures.

In his pulpit performances he spoke very rapidly - without giving himself much time, it would seem, to evolve an idea, yet his discourse were systematic, and the subject matter treated

always had ample justice done it. His method or manner of speaking induced some of his critical hearers to allege that he memorized his sermons, and depended more upon his memory than the strength and quickness of his intellect. His sermonizing became a theme of discussion and wonder. That he had a superior memory we shall not for a moment urge a doubt, but his intellect was also of the highest order and ever ready to serve him. He once stopped with us to rest for a night, and being doubtless

more hungry for mental food than for that which perisheth, after a few common place and agreeable words he directed his way to our little library and very opportunely laid his hand on the poems of John Milton, and commenced reading his "Paradise Lost and Regained." The more he read the more he became interested, until finally, his mind became deeply absorbed in the subject matter of the book. He however found a stopping place and laid aside, and after decanting awhile upon the topics he had just read the matter was dropped, and other subjects taken up and discussed more peculiar to the

ordinary business transactions of life. His colloquial powers being of the first order - social and agreeable - he was of course entertaining. On the next day (Sunday) we went to church, and he preached from Heb. 1: 1,2. And strange to say, in the elucidation of the subject embraced in the text in reference to the creation of man, and of making the worlds in the beginning, he could quote verbatim et liberatim the poems of Milton which he had read the previous evening. It was only necessary for him to read or hear, to have made an indelible impression on his very plastic and retentive mind.

It was not memory alone (much as it contributed) that made Elder Barnett a polished shaft in the quiver of the Lord. Nor was it education or scholastic training, for of that he had but very little. It was the large brain of the man - the gigantic intellectual reasoning powers that he possessed which, combined with the special blessings of rich grace bestowed on him by the Holy Spirit, that enabled him to grapple with the most abstruse and mysterious questions and arrive almost intuitively at sound and orthodox conclusions. His mental powers acted so quickly that little time for reflection was necessary. He was certainly a man of extraordinary gifts, and had language completely

under his control, and he generally clothed his ideas in the best English dress. He was often chosen to preach the introductory sermons at the different sessions of the Association, and to write the circular letters to the churches in union. He was also appointed one of a committee to prepare a Historical Sketch of the Broad River Association, and is substantially the author of the pamphlet purporting to be such a history published in 1871.

The Burial Place of Elder Barnett: El Bethel Church, Cherokee Co., S.C.

El Bethel Church is located some 12 miles south of Gaffney, S.C., on Highway 54. The old house of worship is now abandoned and stands hard by the Cemetery. A new and beautiful house of worship has been erected under the leadership of the Reverend Charles Perry, Jr. The church is now making some spiritual progress and bids fair to grow in the future.

On Wednesday, April 28, 1976, while engaged in a Revival meeting with Rev. Don McCutcheon, of the Nazareth Baptist Church. Blacksburg, S.C., Rev. Charles Perry, Pastor of El Bethel Church (once Union County) now Cherokee Co., S.C. led us to the burial place of Elder M.C. Barnett. His "Marker" is a tall shaft, some seven or more feet in height. His legend reads:

"Elder M.C. Barnett - born May 20, 1818 - died Sept. 19, 1872." A large Masonic Emblem is carved near the top. No marker is erected to commemorate his wife's death or burial. The Words: "Erected by the Baptists" is inscribed on the marker.

Micajah Cicero Barnett was pastor of the church in 1863 and continued in this capacity through 1866. He was ordained to the gospel ministry by the Cedar Spring Baptist Church in Spartanburg County, S. C., on December 24, 1842. Drury Scruggs, Simpson Drummond, John G. Landrum, Felix W. Littlejohn and Elias Rogers constituted the presbytery. Examination was by Felix Littlejohn and the ordination prayer was by Elias Rogers. John G. Landrum, moderator of the presbytery, delivered the charge to the candidate.

He married Nazareth Lipscomb, daughter of Edward Lipscomb, deacon of Goucher Creek Church.

M. C. Barnett, nephew of Joroyal Barnett, was born May 20, 1818, and departed this life September 20, 1872, at Shelby, N. C. John G. Landrum delivered his funeral discourse to a large and sympathizing congregation. He was buried in the El Bethel Baptist Church cemetery with Masonic honors. Nazareth Barnett was born September 4, 1819, and died December 27, 1889. She was buried at Bethel cemetery in Woodruff, S. C., where she had moved after the death of her husband. She lived with her daughter, Martha S. Barnett Ezell, wife of the Reverend Landrum C. Ezell.

The battles of the Confederacy were fought not only on the battlefield, they were also fought by the women of the homes through heroic efforts to provide for their families, and through sublime self-sacrifice for the sake of our soldiers. They did not fight, but at home they labored earnestly, endured hardships and prayed fervently for the soldiers' safe return.

After the cruel war was over the men came home, some on horseback, and many on foot all the way from Virginia. And the pastors provided comfort to those, whose loved ones had been lost in the battles, and encouragement for those who returned with emotional scars and physical wounds. The Heavenly Father sent M. C. Barnett to the Gilead church for such a time as this.

And to those who bore the storm and stress and tragedy of those dark days, it is good to remember that the sun which set in blood and ashes over the hills of Appomattox has risen again in splendor on the smiling prospects of a New South. Its because the foundation of its success was laid in the courage, steadfastness and hopefulness of a generation who in the darkest days of disaster did not despair of their country.Rev.
