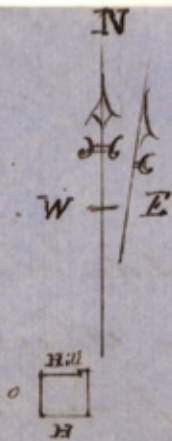

 for the Sale of Public Domain, said Survey is  
 situated in Pandora County on the East side of  
 the Sabine River, and on Jacksons creek a tributary  
 of the Sabine & about  $\frac{1}{4}$  miles  $N. 36^{\circ} E$  from the  
 Town of Carthage Beginning at the S. E  
 corner of Jesse Mc Hills' survey at a Stake  
 a Stake from which a White Oak Bus. N. 40 W.  
 4 vrs. & a sweet gum Bus. South & var mark'd  
 J. M. H. Hence West with said Hills S. Boundary  
 line and at 720 vrs. intersected J. Oliphants'  
 N. E corner a Stake from which <sup>over cup</sup> a Oak Bus  
 S 66 W. 20 vrs. and a Ditto — Bus. S 25 W.  
 167 1/2 vrs. each mark'd J. O. Hence South with said

The State of Texas } Know all men by these  
Paula County. } present that I John E  
Caroline of the aforesaid State & County do this  
day being December 17<sup>th</sup> 1860 relinquish & release  
~~all claim~~ <sup>land</sup> as public Domain, the ~~same~~ I  
took & had surveyed by L D McJimney  
County Surveyor of Paula County under a preemption  
Affidavit proved up under the Act of this  
State approved Feb'y 1<sup>st</sup> 1860 for the sale  
of the Public Domain to preemption settlers;  
Hereby permitting by this act of mine, the  
said land to revert to the state as  
public Domain, and do hereby forfeit  
any right I may hereafter have, to prove  
up and apply to myself any other preemp-  
tion under any law now in force.

And give & grant the said land to  
be taken up by any other person the right  
to preemt on the same to enter it by  
a file on a certificate or in any manner  
he or they may choose, given under my  
hand, and seal, using a mark for  
the same.
