

as a genuine claim against the Government
and issued in conformity with Law.

Know all men by these presents that I Levi W. White of said County and State -
am held and firmly bound unto Lodowick E. Downes of the above named County and State in the just and full sum of five hundred dollars (lawful money of this State, the payment of which well and truly to be made, I bind myself, my heirs, Executors and Administrators, firmly by these presents.

The Condition of the above obligation is such that where as the said Levi W. White for the Consideration of the sum of Seventy two 50/100 dollars to me in hand paid by said Lodowick E. Downes, the Receipt whereof is truly acknowledged, I do hereby bargain, sell, grant and convey unto said L. E. Downes, his heirs and assigns a portion of my headright Certificate, to wit three hundred and twenty acres of the same, (heretofore uncultivated by me,) the whole amount of my said headright ~~being~~ Certificate being one third of a League (thirteen hundred & seventy six acres) granted to me, by the Board of Land Commissioners for Houston County on the 3rd day of February - A. D. 1838 - and numbered Sixty seven (67) Trust -

To have and to hold the said three hundred and twenty acres, out of my said headright Certificate, for one third of a League of land, (No. 67) unto the said Lodowick E. Downes, his heirs and assigns forever -

And of the said Levi W. White do warrant the
aforesaid Certificate to be genuine,

And do
furthermore hereby empower the said Lodowick
P. Downes, his heirs, or assigns, to apply for, and
obtain, a Patent from the Government or
any proper authority in the State of Texas,
for the same, in his, or their own name.
Hereby certifying all the said Downes, his heirs,
or assigns, may lawfully do in the
premises,

Now if the above and foregoing
Conditions, of this obligation shall be well
and truly Complied with on the part of
said White, so that the said Downes shall
obtain a Patent, from the Government as
therein specified - then the above, and foregoing
obligation to be null and void, other-
wise to be, and remain in full force
and effect,
