

Know all men by these presents that I Lion Pritchard of said County & State aforesaid do hereby nominate constitute and appoint John Box also of said County & State My My True and Lawful attorney to act in the Procuring of a Land Certificate from the General Land office which Certificate or Warrant was located and returned by the County Surveyor of this County ~~and for his return~~ to the General Land office of the Republic of Texas which location is reported to have been made on the Eleven League claim on Trinidad River and which Warrant or Certificate My said attorney will give the necessary Receipts and all other acts which may be necessary in the Premises and they shall be as binding as if I were present to do and act for my self &c
